### *Forklifts / Powered Industrial Trucks*

Forklifts, also referred to as Powered Industrial Trucks (PIT)<sup>1</sup>, are tremendously useful for a number of tasks because of their ability to move material in a variety of ways. However, forklifts can be dangerous machines – in 2007 there were 77 forklift-related fatalities<sup>2</sup>. Due to the risk of serious injury, forklift safety is regulated by federal and state agencies.

#### **The Occupational Safety and Health Administration (OSHA) Standards**

The federal OSHA standards for forklifts (29 CFR 1910.178) require that:

- Forklift operators must be properly trained.
- Forklifts must be inspected.
- Forklifts must be maintained.

Note: Other federal and state laws may also apply. Employers should consider consulting trade associations as well as a lawyer familiar with OSHA and state safety standards for additional information.

#### **What Does This Mean for Employers?**

##### **Training**

OSHA requires that all forklift operators be properly trained in accordance with specific OSHA training standards. Employers can meet this requirement by either utilizing a qualified in-house associate(s) to conduct a compliant training program or they can seek out a qualified vendor to provide such a program. At the conclusion of this training, the employer must complete a written certification confirming the employee is properly trained to operate a forklift in accordance with OSHA standards.

### Inspections

There are also requirements for refresher training under certain select circumstances relating to the unsafe operation of a forklift or a change in equipment or work environment. (Note: it is a violation of federal law for anyone under the age of 18 years old, regardless of training, to operate a forklift.)

OSHA requires all forklifts be examined at least daily and suggests a pre-operation inspection as well as an operational inspection. Inspection checklists must be retained so the employer can document inspection procedures to OSHA or other regulatory agencies, if necessary.

### Maintenance

Any defects noted in the inspection process must be immediately noted by the employer and corrected. A forklift deemed unsafe must be removed from service and repaired only by authorized personnel. Maintenance records must be retained so the employer can document proper maintenance procedures to OSHA or other regulatory agencies, if necessary.
